WHEREAS, in terms of section 14(3)(a) of the NCTE Act 1993, WRC granted recognition to SHRI CHOUHAN INSTITUTE OF EDUCATION, KHASARA NO. 128, VILLAGE - SUNKHEDI, POST OFFICE - KOLAR, TEHSIL - BHOPAL, DISTRICT - BHOPAL, MADHYA PRADESH for D.El.Ed. course vide order dated 06.01.2011 for an annual intake of 50 students.

AND WHEREAS, the institution applied for change of name of D.El.Ed course from SHRI CHOUHAN INSTITUTE OF EDUCATION to CHOUHAN COLLEGE OF EDUCATION.
